The works detail specification are given below :-

The quotation will be opened on the on 20/10/2017 at 4 P.M if possible and the merit list shall be displayed in the notice board after observing all codal procedures . The interested participants or their representatives are requested to remain present during opening of the tender box.

The earnest money in the shape of D. Call of Rs. 20,000/ =(Rupees Twent thousand) only may be deposited in favour of Block Development Officer, Chandipur RD Block, Unakoti, from any recognized Bank and the said D. Call should be attached with the quotation. The specified quotation form may be collected from BDO's Office, Chandipur with a cost Rs. 1000/- per form after duly signing in the register kept for the purpose.

TERMS AND CONDITION

1. The rate should be quoted both in the figure and words inclusive of all taxes and charges including transportation cost and fitting and fixing at the works site which includes any site within geographical boundary of each GPs/VCs under Chandipur RD Block.
2. The quotation should be dropped in the specified tender box in the Block Head Quarter, Chandipur RD Block
3. The material should be supplied as per specification of the tender/ quotation and within 3(three) days from the date of issuance of supply order.



4. Un-specified material / work will not be received and its should be replaced as per terms and conditions. The replacement may also be ordered even after receipt of the articles and in case any deviation of quality is found.
5. Refund of earnest money will be held up till completion of supply of the materials and the same may be forfeited in the supplier, after being awarded with supply order, fails to supply the materials as per specification within the stipulated period.
